May kindly see the online property statements received from Sri Hemant Kumar-II, Additional District & Sessions Judge, Bulandshahr regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.43,87,673/- (Gross salary is Rs.40,96,273/- & agricultural income of Rs.2,91,400/-) and total deductions/ repayment/ savings/ investment against GIS, GPF, Income Tax, Insurance policies, PPF a/c, Mutual fund, PLI, Home loan and the balance of his savings bank account(s) enhanced for Rs.23,277/- this financial year from previous year's balance, total of which is Rs.20,22,175/-. Thus, a sum of Rs.23,65,498/- was therefore available with him to meet out the household expenditure of his family consisting five members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his mother is drawing Rs.60,000/- per annum from LIC as Pradhan Mantri Vaya Vandana Yojna and also Rs.2,000/- from Agriculture. Being a senior citizen, she resides with him and contributes some amounts for household expenses. His wife is diploma degree holder from VLCC, derives her income approx. 2.5 lacs to 3 lacs from profession.

In this connection it is submitted that he has submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Shahjahanpur in the mIsC. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 firstly vide online dated 10.11.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Hemant Kumar-II, Additional District & Sessions Judge, Bulandshahr be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Bulandshahr Judgeship for His Lordship's kind perusal and orders?
