May kindly see the online 17.09.2020 received from Sri Mayank Kumar Jain, the then District and Sessions Judge, Agra presently posted as District & Sessions Judge, Gonda regarding submission of statements of movable and immovable properties for the financial years 2018-19 and 2019-20 on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-19 and 2019-20 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

- 1. In the financial year 2018-19, his gross income from salary and other sources is Rs. 31,79,119/- (Rs. 31,19,001/- from salary, Rs. 18,782/- from bank interest, Rs. 7,473/- from RD and Rs. 33,863/- from honorarium) and total deductions /Savings/investments against GPF, GIS, Income Tax , insurance donation RD and PPF is Rs. 14,02,671/-. Thus a sum of Rs.17,76,448/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-19. The balance of Rs. 4,59,417/- has decreased from his saving bank A/cs against the balance of the previous year.
- 2. In the financial year 2019-20, his gross income from salary and other sources is Rs. 32,82,081/- (Rs. 26,22,713/- from salary, Rs. 22,266/- from RD, Rs. 6,22,266/- from RD maturity and Rs. 14,836/- from honorarium) and total deductions /Savings/investments against GPF, GIS, Income Tax , insurance donation RD, PM cares and PPF is Rs. 18,98,402/-. Thus a sum of Rs.13,83,679/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2019-20. The balance of Rs. 3,36,112/- has decreased from his saving bank A/cs against the balance of the previous year

In this connection it is submitted that the officer has already submitted his property statements up to the financial year 2017-18 which has already been seen by Hon'ble the then Chief Justice, Allahabad High Court in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2018-19 and 2019-20 have been submitted by the Officer vide his online application dated 17.09.2020 which is due to be submitted up to the end of the financial year 2020-21. As such, there is no delay in submitting the property statements from the part of the officer.

Hon'ble The Administrative Committee vide minutes dated 11.02.2021 has resolved that- "The property statements be submitted before The Hon'ble Administrative Judge of the district where the officer is posted".

May, if approved, the movable and immovable property statements for the financial years 2018-19 and 2019-20 of Sri Mayank Kumar Jain, District and Sessions Judge, Gonda be laid before Hon'ble Mr. Justice Vivek Agarwal, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and orders?
