May kindly see the property statement submitted online received from Sri Ramesh Singh, Principal Judge, Family Court, Kasganj regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial year 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial year 2017-18, Gross income is Rs.19,26,393/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, PLI, FD and Car loan are Rs.12,77,941/-. Thus, a sum of Rs.6,48,452/- was therefore available with him to meet out the household expenditure of his family consisting three members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.7,011/- this financial year from previous year's balance.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2009-10 which had already been seen by Hon'ble Mr. Justice Devendra Pratap Singh, the then Administrative Judge, Bulandshahar. Property statements of the financial years 2010-11 to 2013-14 be laid before Hon'ble Mr. Justice Vipin Chandra Dixit, Administrative Judge, Kasganj Judgeship for His Lordship's kind perusal & orders (in the misc. file of the officer) and statement of 2014-15, 2015-16 & 2016-17 has been submitted online on Application-IDs 46, 66 & 134 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statement for the financial year 2017-18 firstly vide online dated 19.10.2019. As such, there is delay in submitting the same from the part of the officer for which officer has "apologized for late submission of the aforesaid property statements due to excessive work and assured to be careful in future" mentioned in attachment.

May, therefore, if approved, property statements for the financial year 2017-18 of Sri Ramesh Singh, Principal Judge, Family Court, Kasganj be laid before Hon'ble Mr. Justice Manish Kumar, Administrative Judge, Kasganj Judgeship for His Lordship's kind perusal and orders?
