May kindly see the online property statements received from Km. Rekha Agnihotri, Presiding Officer, Motor Accident Claims Tribunal, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income from salary is Rs.57,87,898/- and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, GPF, Income Tax, PPF, FD, Insurance policies and loan are Rs.46,00,426/-. Thus, a sum of Rs.11,87,472/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years. And the balance of her savings bank account(s) has also been reduced for Rs.12,233/- this financial year from previous year's balance.

In this connection, it is submitted that she has already submitted her property statements upto the financial years 2016-17 which had already seen online by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Ghaziabad on eService ID P00001372019 and for the property statement of the financial years 2017-18, a detailed online office note has been laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow for His Lordship's kind perusal and orders on eService ID P00001382019.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 18.12.2021. As such, there is delay in submitting the same from the part of the officer for which she has stated (in her verbatim) that "In March 2021 due to rush of work as incharge District Judge the same could not be sent. In April 2021, all the family members suffered from Covid and thereafter the undersigned became serious and remained hospitalised in Covid Ward, KGMU. Due to trauma of illness and after effect of Covid, the undersigned forget to submit property statement in time and the same was submitted in Dec.2021. It is, therefore, requested to kindly place my property statement before the Hon'ble Court for kind consideration and condonation of delay in submitting property statement", mentioned in her reply dated 08.03.2024..

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Km. Rekha Agnihotri, Presiding Officer, Motor Accident Claims Tribunal, Lucknow be laid before Hon'ble Mr. Justice Kshitij Shailendra, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
