May kindly see the property statement submitted online received from Sri Radhey Mohan Srivastava, Additional District & Sessions Judge, Gonda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.54,33,535/- (income from salary is Rs.39,47,215/-, arrear of IR of Rs.3,81,395/-, arrear of extra increment of LLM degree of Rs.7,31,115/-, Bank interests of Rs.3,50,810/- and income from agricultural land of Rs.23,000/-) and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, purchase of flat, loan, PPF, Sukanya Samriddhi Yojna, Insurance policies, Mutual Fund and FDR are Rs.43,53,597/-. Thus, a sum of Rs.10,79,938/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20. And the balance of his savings bank account(s) is also reduced for Rs.3,52,784/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16, which has already been seen and property statement of the financial years 2016-17 & 2017-18 has been submitted before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for kind perusal and orders on the detailed office note, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 02.12.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Radhey Mohan Srivastava, Additional District & Sessions Judge, Gonda be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda Judgeship for His Lordship's kind perusal and orders?
