May kindly see the property statement submitted online, received from Km. Nisha Srivastava, Additional Director (Law), Directorate of Rev & Spl Intelligen, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2016-17 & 2017-18, total income is Rs.28,77,784/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Ioan and PPF a/c are Rs.10,69,769/-. Thus, a sum of Rs.18,08,015/- was therefore available with her to meet out the household expenditure of herself in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs.14,241/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2009-10 which had already been seen by Hon'ble Mr. Justice Abdul Mateen, the then Administrative Judge, Lucknow with the direction issued to the officer to be careful in future for submitting her property statements, in the misc. file of the officer. And of the financial years 2010-11 & 2011-12, 2012-13 & 2013-14 and 2014-15 & 2015-16 are already processed & separate notes has made on e-service id no.477, 478 and 479 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 firstly vide online dated 28,09.2020. As such, there is delay in submitting the same from the part of the officer for which she has stated that "her father has been expired before joining into judicial service and after joining, her three sisters marriage has solemnized till 2011. Her mother, living with her, has slipped & fractured her leg, which has operation by the Doctors but not successful. After that, her mother has also heart problems and died on 11.03.2014 during her heart surgery. In the aforesaid circumstances, she was mentally & physically very disturbed and forget to submit the property statements in time and assured to submit the statements within time in future, mentioned in her attachment dated 26.09.2020.

May, therefore, if approved, property statements of the financial years 2016-17 & 2017-18 of Km. Nisha Srivastava, Additional Director (Law), Directorate of Rev & Spl Intelligen, Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
