May kindly see the online property statements received from Sri Mahesh Kumar, Additional District & Sessions Judge, Saharanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross salary is Rs.34,39,963/- and total deductions/ repayment/ savings/ investment against GIS, NPS, Income Tax, Car Loan, LIC policies, PPF a/c and the balance of his savings bank account(s) has also been enhanced for Rs.10,30,932/- this financial year from previous year's balance, total of which is Rs.28,89,347/-. Thus, a sum of Rs.4,50,616/- was therefore available with him to meet out the household expenditure of his family consisting four members in both of the financial years.

Officer has stated in his reply dated 23.01.2023 that he has an average household expenditure of Rs.10,000/- maximum for a month which would sometimes be less than Rs.10,000/- or sometimes be a little more than of Rs.10,000/-. Thus, it would be Rs.1,20,000/- in total for a year and for two year it would be Rs. 2,40,000/- approximate.

He has four family members consisting him, his wife and two daughters. His younger daughter was born in the month of November,2016 and she was 3 years old in 2019 and 4 years old in 2020. She was not get admitted in school in that years due to lesser age and covid-19 pandemic. Only one elder daughter was going school in that two years. So there was not much expenses regarding the school fee because most of the time the schools were closed due to pandemic covid-19 in the year of 2020. Most of the time people were confined to their homes. Thus in this way, he has managed his household expenditures of his four family members in the financial year 2018-20.

In this connection, it is submitted that he has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Pratapgarh, placed in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 21.11.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Mahesh Kumar, Additional District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
