

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Smt. Pragya Singh-I, Additional Principal Judge, Family Court, Lucknow regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2011-13 (2011-12 and 2012-13) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2011-13 (2011-12 and 2012-13) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

In the financial years 2011-13 (2011-12 and 2012-13), her gross income from salary is Rs.14,14,895/- and total deductions/Savings/investments GIS, Income Tax, PPF, RD and Insurances are Rs.4,41,203/-. The balance of Rs.41,024/- has increased from her saving bank A/c's against the balance of the previous year. Thus a sum of Rs.9,73,692/- was therefore available with her to meet out the household expenditure of her family consisting three members in the financial years 2011-13 (2011-12 and 2012-13).

It is to pertinent mention here that officer's husband [Government Service] having annual income was Rs.4,54,141/- for the financial years 2011-12 and Rs.4,97,974/- for the financial 2012-13 respectively.

In this connection, it is submitted that the Officer has already submitted her property statement for the financial years 2009-11 offline. Which had already been seen by Hon'ble Mr. Justice Mahesh Chandra Tripathi, the then Administrative Judge, Lucknow Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2011-13 (2011-12 and 2012-13) in its next financial year i.e., 2013-14 upto March 2014. She had firstly submitted movable and immovable property statements for the financial years 2011-13 (2011-12 and 2012-13) vide online dated 02.10.2020 on eServicesJo portal. As such, there is delay in submitting the same. In this regard, officer's verbatim: ".....Excessive workload and due to Maternity Leave and Child Care Leave the property statement could not be submitted within time. Delay is truly regretted" mentioned in the remark column of movable proforma.

May, therefore, if approved, property statements for the financial years 2011-13 (2011-12 and 2012-13) of Smt. Pragya Singh-I, Additional Principal Judge, Family Court, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
