May kindly see the reply submitted online dated 17.02.2022 received from Sri Suryabhan Kumar Verma, Additional Chief Judicial Magistrate, Raebareli, in compliance of order of Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Raebareli in the matter of property statement, communicated to the officer.

As it is required to be clearly mentioned in each and every year as both old and new acquisition with its supporting details, the officer was requested vide Court's online communication dated 29.01.2022, to prepare a new chart accordingly and submit it immediately, so that the same may be placed before the Hon'ble Court, for further orders in the matter.

After that, the officer has attached <u>"new chart"</u> in the attachment dated 17.02.2022 in the aforesaid statements, according to which the details of his property held year wise are follows:
