Thus a sum of Rs. 43,40,138/-/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife Mrs. Deepa Rai is Additional District and Sessions Judge, Hardoi and her income including salary and allowances is 1,63,189/- per month in this financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2016-18 (2016-17 & 2017-18) which had already been seen by Hon'ble Mr. Justice Alok Mathur, the then Administrative Judge, Firozabad in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 12.10.2020. As such, there is no delay in submitting the same from the part of the officer.
