May kindly see the property statement submitted online received from Smt. Mita Kumari, presently posted as Special Judge (SC/ST, Prevention of Atroci Act), Gonda regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2012-14 (2012-13 & 2013-14) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2012-14 (2012-13 & 2013-14) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year, 2012-14 (2012-13 & 2013-14), her Total income from salary and interest is Rs. 20,31,260/- total deductions/savings/investments against GPF, GIS, Income Tax, PPF and Insurances (LIC & PLI) is Rs. 7,82,178/-. Thus a sum of Rs. 12,49,082/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 4,02,656/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Project Manager, J.P. Associates, presently posted as Team Leader, LEA Associates Pvt. Ltd. and his annual income from salary and other sources (salary and interest) is Rs. 10,66,459/- and 12,00,746/- respectively in both the financial years.

In this connection, it is submitted that the officer has already submitted her property statements offline for the financial years 2010-12 and seen by Hon'ble the Chief Justice in the Misc.file of the Officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2012-14 (2012-13 & 2013-14) in its next financial year i.e., 2014-15 upto 31st March 2015. She has submitted movable and immovable property statements for the financial years 2012-14 (2012-13 & 2013-14) firstly vide her application dated 17.10.2020. As such, there is delay in submitting the same from the part of the officer and she has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2012-14 (2012-13 & 2013-14) of Smt. Mita Kumari, presently posted as Special Judge (SC/ST, Prevention of Atroci Act), Gonda, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for His Lordship's kind perusal and orders?
