May kindly see the property statement submitted online received from Sri Bans Bahadur Yadav, presently posted as Presiding Officer, Commercial Court, Kanpur Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary is Rs. 48,38,924/- and total deductions/savings/investments against GPF, GIS, Income Tax, PPF approx, Insurances (LIC, HDFC Bank Policy, Reliance Life Insurance and SBI Life) and Home Loan (2 Residential Flats) is Rs. 26,85,139/- (including enhancement of Rs. 3,08,000/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 21,53,785/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both the financial years.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 22.10.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Bans Bahadur Yadav, presently posted as Presiding Officer, Commercial Court, Kanpur Nagar, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Kanpur Nagar Judgeship for His Lordship's kind perusal and orders?
