In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year, 2014-16 (2014-15 & 2015-16), her Total income from salary and other sources is Rs. 25,59,948/- (Total Salary Rs. 25,35,485/-, bank Interest Rs. 17,716/- Honorarium Rs. 6,750/-) and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, Insurances (LIC & PLI) and Car Loan is Rs. 15,17,738/- (including enhancement of Rs. 2,75,123/- in his S.B. A/cs against the balance of the previous year) Thus a sum of Rs. 10,42,210/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both the financial years.

It is pertinent to mention here that her husband is Project Manager, JP Associates, presently posted as Team Leader, LEA Associates Pvt. Ltd. and his annual income from salary and other sources (salary and bank interest) is Rs. 11,92,712/- and 12,32,299/- respectively in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2012-14 (2012-13 & 2013-14) which is also processed online and laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for kind perusal and order on eservice Id no. 1614.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto 31st March 2017. She has submitted movable and immovable property statements for the financial years 2014-16 (2014-15 & 2015-16) firstly vide her application dated 17.10.2020. As such, there is delay in submitting the same from the part of the officer and she has not given any reason for delay.
