May kindly see the property statement online received from Sri Vivek Kumar Singh-II, Civil Judge (Senior Div.), Deoria regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2017-19 (2017-18 & 2018-19), Gross income from salary is Rs. 22,74,384/- and total deductions/savings/ investment against NPS, GIS, PPF, Income Tax, Insurances, Mutual Funds and the balance of his savings bank account(s) is also enhanced by Rs.9,76,401/- in this financial year from previous year's balance, total of which is Rs.16,90,049/-. Thus, a sum of Rs.5,84,335/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

It is pertinent mention here that officer wife is Sub Registrar Stamp and Registration in Govt of U.P. having annual income Rs. 7,76,630/-.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2015-17 (2015-16 & 2016-17) online against case id- P00007842020(old case id-1630) and same has been processed before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Deoria for His Lordship's kind perusal and orders

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial year 2017-19 (2017-18 & 2018-19) vide online dated 17.10.2020. As such, there is delay in submitting the same. In this regard, officer most humbly requested that he had submitted property statement manually on 23.01.2019 for the year 2017-2019, but it was before due date and not matched with two year interlocking period(Block financial year), so he had submitted statement of year 2017-2019(2017-18 & 2018-19) through online mode..

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Vivek Kumar Singh-II, Civil Judge (Senior Div.), Deoria be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Deoria for His Lordship's kind perusal and orders?
