May kindly see the property statement submitted online received from Sri Mohd. Rashid, A.D.J. (POCSO), Kushi Nagar at Padrauna regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.46,16,099/- (income from salary & arrears is Rs.43,26,099/- and agricultural income of Rs.2,90,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, LIC policies, PPF a/c, SIP, Tuition fees, Tax and EMI are Rs.25,33,576/-. Thus, a sum of Rs.20,82,523/- was therefore available with him to meet out the household expenditure of his family consisting five members in whole of the financial year. And the balance of his savings bank account(s) is also reduced for Rs.91,106/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements upto the financial years 2015-16 which had already been seen by Hon'ble Mr. Justice Bachchoo Lal, the then Administrative Judge, Unnao and for the property statements of the financial years 2016-17 & 2017-18, a detailed office note has been laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 14.10.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Sri Mohd. Rashid, A.D.J. (POCSO), Kushi Nagar at Padrauna, be laid before Hon'ble Mr. Justice Deepak Verma, Administrative Judge, Kushinagar at Padrauna Judgeship for His Lordship's kind perusal and orders?
