May kindly see the property statement online received from Sri Vivek Kumar Singh-II, Civil Judge (Senior Div.), Deoria regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2015-17 (2015-16 & 2016-17), Gross income from salary is Rs. 13,88,501/- and total deductions/savings/ investment against GIS, PPF, Income Tax, Insurances and the balance of his savings bank account(s) is also enhanced by Rs.5,55,506/- in this financial year from previous year's balance, total of which is Rs.8,36,537/-. Thus, a sum of Rs.5,51,964/- was therefore available with him to meet out the household expenditure of his family consisting three members in the both of the financial year.

It is pertinent mention here that officer wife is Sub Registrar Stamp and Registration in Govt of U.P. having annual income of Rs. 6,15,510/-.

In this connection, it is submitted that the Officer has already submitted his property statement at the time of Joining into U.P. Judicial Service, which has been seen Hon'ble Mr. Justice Sanjay Harkauli, the then Administrative Judge, Amedkar Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements of the financial year 2015-17 (2015-16 & 2016-17) vide online dated 25.08.2021. As such, there is delay in submitting the same. In this regard, officer stated that due to mode balance attached with his savings account, there was some difficulty to know the exact amount in his savings account. It took some time to know exact savings amount with the help of bank.
