May kindly see the property statement submitted online received from Smt. Mita Kumari, presently posted as Special Judge (SC/ST, Prevention of Atroci Act), Gonda regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year, 2018-20 (2018-19 & 2019-20), her Total income from salary and other sources is Rs. 53,27,858/- (Total Salary Rs. 44,61,710/-, bank Interest Rs. 149156/- PLI policy maturity(non taxable) Rs. 2,93,202, and FDR Maturity Rs. 4,23,790/-) and total deductions/savings/investments against GPF, NPS, GIS, Income Tax, PPF, Insurances (LIC & PLI), and FDRs is Rs. 35,18,010/-. Thus a sum of Rs. 18,09,848/- was therefore available with her to meet out the household expenditure of her family consisting of three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs. 3,76,184/- this financial year from previous year's balance.

It is pertinent to mention here that her husband is Team Leader, LEA Associates Pvt. Ltd. and his annual income from salary and other sources (salary, interest and Gratuity non-taxable) is Rs. 13,23,211/- and 11,52,087/- respectively in both the financial years and also her son Dr. Shubhang Singh earned Rs. 1,62,000/- (amount till December 2018) from Medical Internship stipend.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2016-18 (2016-17 & 2017-18) which is also processed online and laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for kind perusal and order on e-service Id no. 1670.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide her application dated 17.10.2020. As such, there is no delay in submitting the same from the part of the officer for no reason has been mentioned by the officer.
