May kindly see the property statement received online from Sri Ramesh, Spl. J, Spl C. No 1 (Pre.Cor. Act), Meerut, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2014-2016 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2014-2016 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2014-2016 (2014-15 & 2015-16), the Gross income from salary is Rs.26,60,026/- and total deductions/savings/investment against GIS, GPF, PPF, Insurances, loan repayments and Income Tax is Rs.10,24,175/- and the balance of his savings bank account(s) is also increased by Rs.2,32,961/- in this financial year from previous year's balance, total of which is Rs.12,57,136/-. Thus, a sum of Rs.14,02,890/- was therefore available with him to meet out the household expenditure of his family consisting seven members of the financial year 2014-2016 (2014-15 & 2015-16).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2012-13 & 2013-14 offline and the same has been seen by Hon'ble Mr. Justice Shri Narain Shukla, the then Administrative Judge, Varanasi Judgeship, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2014-2016 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has firstly submitted movable and immovable property statements of the financial year 2014-2016 (2014-15 & 2015-16) vide online dated 13.10.2020. As such, there is delay in submitting the same from the part of the officer, for which the officer has stated that *"due to personal and family problems I was not able to collect all the relevant documents relating to my property statement and same were not submitted on time. I am apologize for same and I assure that this will not be repeated again in future"*, mentioned in the remark column of movable proforma.

May, therefore, if approved, property statements for the financial year 2014-2016 (2014-15 & 2015-16) of Sri Ramesh, Spl. J, Spl C. No 1 (Pre.Cor. Act), Meerut, be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Meerut Judgeship for His Lordship's kind perusal and orders?
