

## **Registrar(Judicial)(Budget)**

May kindly see the property statement online received from Sri Vipin Kumar-III, Special Judge, Spl C. No 5 (Pre. Cor. Act), Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

**(1) In the financial years 2016-18 (2016-17 & 2017-18)**, total income is Rs.28,75,014/- (Income from salary is Rs.26,15,014/- & Income from S.B. a/c Rs.2,60,000/-) and total deduction/ repayment/ savings/ investment/ against C.P.F., G.I.S., Income Tax, L.I.C., P.P.F. are Rs.26,01,148/- (including enhancement of Rs.15,26,119/- in his S.B. A/c against the balance of the previous year). Thus, a sum of Rs.2,33,866/- was available with him to meet out the household expenditure of his family consisting four members for the financial year 2016-18 (2016-17 & 2017-18).

It is pertinent to mention here that his wife Dr. (Smt.) Mahima Nimi BHMS Rs 30,000/- Per Month approximately.

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2014-16 which has been processed before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship on old case ID no-1657.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e. 2018-2019 upto March, 2019. He has submitted movable and immovable property statements of the financial years 2016-18 (2016-17 & 2017-18) vide online letter dated 21.07.2021. As such, there is delay in submitting the aforesaid property statements from the part of officer for which no reason has been given.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Vipin Kumar-III, Special Judge, Spl C. No 5 (Pre. Cor. Act), Gorakhpur, be laid before Hon'ble Mr. Justice Shekhar B. Saraf, Administrative Judge, Gorakhpur Judgeship for His Lordship's kind perusal and orders?
