In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.53,23,994/- and total deductions/savings/investment against GIS, GPF, PPF, Insurances and Income Tax is Rs.20,07,499/- and the balance of his savings bank account(s) is also increased by Rs.11,58,845/- in this financial year from previous year's balance, total of which is Rs.31,66,344/-. Thus, a sum of Rs.21,57,650/- was therefore available with him to meet out the household expenditure of his family consisting seven members of the financial year 2018-2020 (2018-19 & 2019-20).

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 31.10.2020. As such, there is no delay in submitting the same.
