May kindly see the online application received from Sri Mohammed Qamruzzama Khan, the then Addl. District and Sessions Judge, Etawah presently posted as Addl. District & Sessions Judge, Banda regarding submission of statements of movable and immovable properties for the financial years 2014-15 and 2015-16 on proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-15 and 2015-16 of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial years 2014-15 and 2015-16, his gross income from salary is Rs. 24,32,318/- (Rs. 24,02,318/- from salary and Rs. 30,000/- from agriculture) and total deductions/Savings /investments against NPS, GIS, TDS, PPF, Insurances and RD is Rs.17,45,456/- (including enhancement of balance of Rs. 1,68,717/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs.6,86,862/- was therefore available with him to meet out the household expenditure of his family consisting of 4 members in the financial years 2014-15 and 2015-16.

It is pertinent to mention that the wife of the officer, Smt. Saima Jalis, is a Deputy Jailor in U.P Government whose monthly income is Rs. 42,000/- in the financial years 2014-15 and 2015-16.

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2013-14 which has already been seen by Hon'ble Mr. Justice A.P. Sahi, the then Administrative Judge, Ghaziabad in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 have been submitted by the Officer vide his online application dated 15.10.2020 which were due to be submitted upto the end of the financial year 2016-17. As such, there is delay in submitting the property statements from the part of the officer for which he has stated that he had submitted the information of residential plot purchase but was not aware of submitting the property statements and apologised for the delay caused.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Mohammed Qamruzzama Khan, Addl. District and Sessions Judge, Banda kindly be laid before Hon'ble Mr. Justice Rajesh Singh Chuahan, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
