In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2018-20 (2018-19 & 2019-20), Total income from salary is Rs.48,68,209/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, LIC policy, NPS(PRAN), Sukanya Samridhi Yojna, repayment of Home loan and the balance of his savings bank account(s) is enhanced by Rs.76,648/- this financial year from previous year's balance, total of which is Rs.47,46,149/-. Thus, a sum of Rs.1,22,060/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

It is pertinent to mention here that wife of the officer Smt. Pushpa is an Assistant Teacher, her monthly income is Rs.56,000/- for the F.Y. 2018-19 & Rs.62,000/- for the F.Y. 2019-20.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2017-18, which has already been seen offline by Hon'ble Ms. Justice Naheed Ara Moonis, then Administrative Judge, Sultanpur Judgeship, in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. As such, there is no delay in submitting the aforesaid property statements.
