May kindly see the property statement received online from Sri Sanjeev Kumar Singh-II, A.D.J. (POCSO), Baghpat regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.40,35,247/- and total deductions/savings/investment against GIS, GPF, PPF, Sukanya Samriddhi Account, Insurances, Loan repayments including flat booking and Income Tax is Rs.24,09,463/- and the balance of his savings bank account(s) is also increased by Rs.14,634/- in this financial year from previous year's balance, total of which is Rs.24,24,097/-. Thus, a sum of Rs.16,11,150/- was therefore available with him to meet out the household expenditure of his family consisting four members of the financial year 2018-2020 (2018-19 & 2019-20).

In this connection, it is submitted that the Officer has already submitted his property statements for financial year 2008-2010, 2010-2012, 2012-2014, 2014-2016 & 2016-2018 offline and the same has been processed before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders, in the misc file of officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 15.12.2021. As such, there is delay in submitting the same from the part of officer, for which he has stated in his online reply dated 29.08.2023 that *"delay reasons are excess of work in the court and frequent changes of court at previous station. Extremely sorry for delay."*

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Sanjeev Kumar Singh-II, A.D.J. (POCSO), Baghpat, be laid before Hon'ble Mr. Justice Anish Kumar Gupta, Administrative Judge, Baghpat Judgeship for His Lordship's kind perusal and orders?
