May kindly see the property statement submitted online received from Sri Mohammed Qamruzzama Khan, presently posted as Special Judge, (U.P. Dacoity.A.A.), Banda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary and other sources is Rs. 33,76,942/- (Salary Rs. 29,78,951/-, Interest on saving bank Rs. 3,67,991/- and Agricultural Income Rs. 30,000/-) and total deductions/savings/investments against NPS, GIS, TDS, PPF, Insurances and RD is Rs. 28,14,711/- (including enhancement of Rs. 10,64,567/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 5,62,231/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his wife is in Government Service joined in june 2016 as Deputy Jailor and earned Rs. 38,000/- per month.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2014-16 (2014-15 & 2015-16) which is also processed online on e-service Id no. 1666.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 20.10.2020. As such, there is delay in submitting the same from the part of the officer and has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Mohammed Qamruzzama Khan, presently posted as Special Judge, (U.P. Dacoity.A.A.), Banda, be laid before Hon'ble Mr. Justice Rajesh Singh Chuahan, Administrative Judge, Banda for his Lordship's kind perusal and orders?
