May kindly see the property statement received online from Sri Ram Net, Special Judge (E.C. Act), Rae Bareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.36,08,558/- and total deductions/savings/investment against NPS, GIS, Income Tax, LIC, PPF, FD and the balance of his savings bank account is also enhanced by Rs.2,43,266/- in this financial year from previous year's balance, total of which is Rs.18,97,899/-. Thus, a sum of Rs.17,10,659/- was therefore available with him to meet out the household expenditure of his family consisting of five members in both of the financial years. It is pertinent to mention here that his father's annual income from farming is Rs.1,25,000/- & 1,50,000/- (approx), in the financial year 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the Officer has submitted his property statements for the the financial years 2016-18 and the same has been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Auraiya Judgeship, in the misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted his movable and immovable property statement for the financial years 2018-20 (2018-19 & 2019-20) firstly vide online dated 21.10.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Ram Net, Special Judge (E.C. Act), Rae Bareli be laid before Hon'ble Mr. Justice Arvind Singh Sangwan, Administrative Judge, Rae Bareli Judgeship for His Lordship's kind perusal and orders?
