May kindly see the property statement submitted online received from Sri Abhay Prakash Narain, presently posted as Special Judge, Special Court (Pre.Cor. Act) Gorakhpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary and other sources is Rs. 24,56,985/- (Salary Rs. 23,03,708/-, Interest Rs. 13,277/- and Agricultural Income Rs. 1,40,000/-) and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, LIC, Mutual Fund and Bonds is Rs. 10,01,371/-. Thus a sum of Rs. 14,55,614/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs. 1,17,049/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earned Rs. 546000/- from tuition annually.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2014-16 (2014-15 & 2015-16) which is also processed online and laid before Hon'ble Mr. Justice Suneet Kumar, Administrative Judge, Gorakhpur, for kind perusal and order on eservice Id no. 1680.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 31.10.2020. As such, there is delay in submitting the same from the part of the officer and has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Abhay Prakash Narain, presently posted as Special Judge, Special Court (Pre.Cor. Act), Gorakhpur, be laid before Hon'ble Mr. Justice Siddhartha Varma, Administrative Judge, Gorakhpur for his Lordship's kind perusal and orders?
