

**Joint Registrar (Judicial) (Budget)**

May kindly see the property statement submitted online received from Sri Anil Kumar XII, the then Civil Judge (Senior Division), Agra presently Civil Judge (Senior Division), Shravasti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary and other sources is Rs. 22,18,136/- (salary Rs. 20,65,033/- and eRD maturity amount Rs. 1,53,103/-) and total deductions/savings/investments against GPF, GIS, Income Tax, Insurances policy (LIC & S.B.I. Life Saral Savdhan), PPF and the balance of his Saving bank A/c is enhanced for Rs. 10,47,430/- this financial year from previous year's balance, total of which is Rs. 17,15,489/-. Thus a sum of Rs. 5,02,647/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years.

It is pertinent to mention here that his wife earned Rs. 2,87,180/- and 3,02,652/- annually from LIC Commission & Tution for the financial years 2016-17 & 2017-18 respectively.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2014-16 (2014-15 & 2015-16) which is also processed online and laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Shravasti for his Lordship's kind perusal and order on e-service Id no. 1724.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto 31st March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 31.10.2020. As such, there is delay in submitting the same from the part of the officer and he has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Anil Kumar XII, presently Civil Judge (Senior Division), Shravasti be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Shravasti for His Lordship's kind perusal and order?
