In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income is Rs.79,00,653/- . (This includes his salary as Rs. 58,32,253/-, 2 separate LIC insurance payouts as Rs. 1,33,400/- & Rs. 8,65,000/- and income from rent as Rs.10,70,000/-). After total deductions/savings/investments against GIS, GPF, Income Tax, Insurance Policies, PPF, loan and the balance of his Savings bank A/c is enhanced for Rs. 10,97,715/- this financial year from previous year's balance, total of which is Rs.50,24,826/-. Thus a sum of Rs. 28,758,27/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements for 2010-12 which was seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad. The property statement for 2012-14, 2014-16 & 2016-18 has already been processed under ID No. 1271, 1273 & 1272 respectively and has been laid before Hon'ble Mr. Ashutosh Srivastava, Administrative Judge, Hapur, for His Lordship's kind perusal and order?.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 06.11.2020. As such, there is no delay in submitting the same from the part of the officer.
