May kindly see the online letter dated 01.11.2020, received from Sushri Nidhi Yadav, Civil Judge (Sr. Div.), Pratapgarh, through which she has submitted her movable and immovable property statements held at the time of entering i.e., of joining into U.P. Judicial service, the officer has the following movable properties acquired/held, i.e. two necklace set (Gold) 44 gms, 10 Gold Coins-100 gms, two Gold bangles - 40 gms, 6 Gold Rings- 25 gms, Two Gold Chains- 18 gms, One Gold Bracelet- 18 gms, One Forehead Teeka- 12gms, Five earrings-20 gms (Total Value Rs. 8,31,000/-Approx), Three Diamond Set (worth Rs. 2,50,000/- Approx), Silver Utensils- 1Kg., Four Silver Ankelets- 400gms (Total Value of Silver worth Rs. 65,000/- Approx), one Old A.C. (worth Rs. 8,000/- Approx), one Old Zen Estillo Car (Present value Rs. 50,000/- Approx gifted by Father in December, 2016 before joining the service). She has further mentioned that all the items are gifted by her parents, relatives on birth, mundan, marriages in family etc. and from earnings from legal practice before joining the Judicial Service during 2010-2016. Along with this, she has also mentioned that she has a savings account in S.B.I. (A/C No.- 30177050105) opened on 17.10.2014 before joining the service having balance of Rs. 74,690/- as on 13.01.2017, source of which is mentioned as savings from income from practice and another savings account in Vijaya Bank (A/C No.-712301011003802) opened on 20.08.2013 before joining the service, having balance of Rs. 72,514/- as on 13.01.2017, source of this amount is mentioned as savings from income from practice before joining the service. Further, she has also mentioned the details of investment in SBI Life Insurance Policy No. 35011621503 dated 04.07.2011 for 15 years ending on 04.07.2025 (Premium amount- Rs. 30,048/- yearly) and F.D.R. No. 712303681000190 dated 20.03.2013 in Vijaya Bank, RSM Nagar, Lucknow of Rs. 20,00,000/-, source of both the investments has been mentioned as gifted by her father before joining the service.

May, therefore, if approved, property statement at the time of entering i.e., of joining into U.P. Higher Judicial Service of Sushri Nidhi Yadav, Civil Judge (Sr. Div.), Pratapgarh, be laid before Hon'ble Mr. Justice Rahul Chaturvedi, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders?
