May kindly see the property statement online received from Smt. Deepa Rai , Additional District & Session Judge (POCSO) , Firozabad, regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below :

(1) In the financial years 2018-20 (2018-19 & 2019-20), Total Income is Rs. 86,10,971/- (Gross income from salary, Bank interest, Mutual fund (guilt fund) , redemption of shares, maturity of FD, maturity of Bond, withdrawal from PPF) and total deductions/repayment/ savings/ investment against pension fund, PPF, GIS, Income Tax, LIC policies & Max. life insurance , FD, Shares, Bond, SBI Equity Fund and the balance of her savings bank account(s) is also increased by Rs.1,27,085/- in this financial year from previous year's balance, total of which is Rs.43,99,570/-. Thus, a sum of Rs.40,84,316/- was therefore available with her to meet out the household expenditure of her family consisting four members for both the financial years.

It is pertinent to mention here that her husband is also a judicial officer (Addl. District Judge) having monthly income Rs.1,74,238 /- (including salary and allowances).

In this connection, it is submitted that the Officer has already submitted her property statements upto the financial year 2017-18, and the property statement of the financial year 2017-18 has already seen by the Hon'ble Mr. Justice Pankaj Naqvi, the then, Administrative Judge, Hardoi and is kept in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 23/02/2021. As such, the officer has submitted the property statement of the financial year 2018-20 (2018-19 & 2019-20) within time.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Deepa Rai , Additional District & Session Judge (POCSO) , Firozabad, be laid before Hon'ble Mr. Justice Jaspreet Singh, Administrative Judge, Firozabad for His Lordship's kind perusal and orders?
