May kindly see the property statement online received from Sri Prafull Kamal, Additional District & Sessions Judge, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income is Rs.48,34,346/- (income from salary) and total deductions/ repayment/ savings/ investment against GPF, PPF, GIS, Income Tax, Mutual Fund, Insurances, downpayment of car loan, Paid to Omaxe for plot and the balance of his savings bank account(s) is also enhanced by Rs.36,329/- this financial year from previous year's balance, total of which is Rs.29,12,725/-. Thus, a sum of Rs.19,21,621/- was therefore available with him to meet out the household expenditure of his family consisting of four members for both the financial years 2018-19 & 2019-20.

It is pertinent to mention here that his wife Smt. Meena Srivastava, Member Commercial Tax Tribunal, Gorakhpur, Annual Income- Rs. 17,98,129/- and his father Sri Krishna Mohan Srivastava, Retired District & Sessions Judge, Annual Income- Rs.19,86,139/-

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18, which has already been seen by Hon'ble Mr. Justice Rajiv Lochan Mehrotra, the then Administrative Judge, Sant Kabir Nagar in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 05.03.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Prafull Kamal, Additional District & Sessions Judge, Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
