May kindly see the property statement submitted online received from Sri Anil Kumar XII, the then Civil Judge (Senior Division), Agra presently Civil Judge (Senior Division), Shravasti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below:

In the financial year 2014-16 (2014-15 & 2015-16), his Total income from salary is Rs. 16,62,726/ and total deductions/savings/investments against GPF, GIS, Income Tax, Insurances policy (LIC & S.B.I. Life Saral Savdhan), PPF and Car Loan and eRD and the balance of his Saving bank A/c is enhanced for Rs. 1,80,344/- this financial year from previous year's balance, total of which is Rs. 9,00,116/-. Thus a sum of Rs. 7,62,610/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years.

It is pertinent to mention here that his wife earned Rs. 2,18,950/- and 3,18,250/- annually from LIC Commission & Tution for the financial years 2014-15 & 2015-16 respectively.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2013-14 and seen by Hon'ble Mr. Justice Devendra Kumar Upadhyaya, the then Administrative Judge, Aligarh.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto 31st March 2017. He has submitted movable and immovable property statements for the financial years 2014-16 (2014-15 & 2015-16) firstly vide his application dated 27.11.2020. As such, there is delay in submitting the same from the part of the officer and he has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri Anil Kumar XII, presently Civil Judge (Senior Division), Shravasti be laid before Hon'ble Mr. Justice Subhash Chandra Sharma, Administrative Judge, Shravasti for His Lordship's kind perusal and order?
