May kindly see the property statement submitted online received from Sri Ram Manohar Narayan Mishra, Director, Institute of Judicial Training & Research, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2016-17 & 2017-18 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2016-17 & 2017-18, Total income is Rs.39,14,973/- (income from salary is Rs.37,84,973/- and Agricultural income of Rs.1,30,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Insurance policies, PPF a/c and RD are Rs.15,43,108/-. Thus, a sum of Rs.23,71,865/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.98,212/- this financial year from previous year's balance.

It is pertinent to mention here that his elder son is working as Lieutenant, Indian Navy having monthly income of Rs.70,000/- approx.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Vikram Nath, the then Administrative Judge, Lucknow in the misc. file of the officer and of the financial year 2014-15 & 2015-16, which is currently processed on e-service Id no.1069.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-17 & 2017-18 vide online dated 02.12.2020. As such, there is delay in submitting the same from the part of the officer for which the officer has given the reason of delay in the statement of 2014-16 (in e-service Id no.1069).

May, therefore, if approved, property statements for the financial year 2016-17 & 2017-18 of Sri Ram Manohar Narayan Mishra, Director, Institute of Judicial Training & Research, Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
