May kindly see the property statement submitted online received from Sri Ram Manohar Narayan Mishra, Director, Institute of Judicial Training & Research, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.58,06,898/- (income from salary is Rs.56,38,010/-, Agricultural income of Rs.1,40,000/- and SB a/c interests of Rs.28,888/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Insurance policies, PPF a/c, RD and the balance of his savings bank account(s) is enhanced for Rs.9,51,010/- this financial year from previous year's balance, total of which is Rs.30,57,915/-. Thus, a sum of Rs.27,48,983/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his elder son is working as Lieutenant Commander, Indian Navy having monthly income of Rs.90,000/- approx.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Vikram Nath, the then Administrative Judge, Lucknow in the misc. file of the officer and of the financial years 2014-15 & 2015-16 and 2016-17 & 2017-18, which are currently processed on e-service Id nos.1069 and 1725.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 02.12.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Ram Manohar Narayan Mishra, Director, Institute of Judicial Training & Research, Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
