May kindly see the property statement online received from Sri Arun Kumar Pathak, Presiding Officer, Motar Accident Claims Tribunal, Basti regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Total income is Rs.57,76,067/- (Gross income from salary is Rs.44,17,554/- and RD Matured for Rs.13,58,513/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, SBI Life Insurance, RD, Home Loan EMI total of which is Rs.34,04,110/-. Thus, a sum of Rs.23,71,957/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years and the balance of his savings bank account(s) is decreased by Rs.10,45,856/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is earning from teaching and boutique work and daughter is working at Kingsley Eco Asia, Ankaleshwar Gujarat.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2017-18 online and same has been approved by the Hon'ble Mr. Justice Abdul Moin, the then, Administrative Judge, Basti Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2021-22 upto March 2022. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 03.11.2020. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri Arun Kumar Pathak, Presiding Officer, Motar Accident Claims Tribunal, Basti be laid before Hon'ble Mr. Justice Pankaj Bhatia, Administrative Judge, Basti for His Lordship's kind perusal and orders?
