In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income from salary is Rs.21,71,230/- and total deductions/savings/investment against GIS, NPS, PPF, FDR, Insurances, Loan repayments and Income Tax is Rs.10,84,023/- and the balance of his savings bank account(s) is also increased by Rs.34,444/- in this financial year from previous year's balance, total of which is Rs.11,18,467. Thus, a sum of Rs.10,52,763/- was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his wife have annual income of Rs.2.5 lakhs Approx. from Business.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id: P00000832023 and the same has been processed before Hon'ble Mr. Justice Om Prakash Shukla, Administrative Judge, Amroha Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same from the part of officer, for which he stated in the remark column, that:

"Some delay has been occured due to the Covid-19 Pandemic. Regret for any inconvenience if caused by this delay."
