May kindly see the property statement online received from Sri Amit Kumar Pande, Spl. Judge (SC/ST, Pev. of Atroci. Act), Faizabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-2018 (2016-2017 & 2017-2018) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-2018 (2016-2017 & 2017-2018) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2016-2018, total income is Rs. 27,12,374/- (Income from salary) and total deduction/ repayment/ savings/ investment/ against N.P.S., G.I.S., Income Tax, L.I.C., P.P.F. (approx.), P.L.I. are Rs. 10,58,829/- (including enhancement of Rs. 18,965/- in his S.B. A/cs against the balance of the previous year). Thus, a sum of Rs. 16,53,545/- was available with him to meet out the household expenditure of his family consisting four members for the financial year 2016-2018.

It is pertinent to mention here that his mother Smt. Krishna Pandey has earned Rs. 7,00,000/- through rent received from shopping complex, Agriculture and farming in the financial years 2016-2018.

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2014-2016 which had already been seen by Hon'ble Mr. Justice Suneet Kumar, the then Administrative Judge, Moradabad.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2016-2018 (2016-2017 & 2017-2018) in its next financial year i.e. 2018-2019 upto March, 2019. He has submitted movable and immovable property statements of the financial years 2016-2018 (2016-2017 & 2017-2018) vide online letter dated 05.11.2020. As such, there is delay in submitting the aforesaid property statements from the part of officer for which he has submitted that due to workload, then promotion and transfer in the yeat 2018 and therefore due to Corona pandemic, he was not able to submit the statement within stipulated time for which he has also tenders his apologies.

May, therefore, if approved, property statements for the financial years 2016-2018 (2016-2017 & 2017-2018) of Sri Amit Kumar Pande, Spl. Judge (SC/ST, Pev. of Atroci. Act), Faizabad be laid before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad for His Lordship's kind perusal and orders?
