May kindly see the property statement submitted online received from Sri Rakesh Kumar Gautam, Additional District and Sessions Judge (FTC), Mahoba regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary is Rs. 39,95,731/- and total deductions/savings/investments against GIS, CPF, TDS, PPF (approx) and the balance of his Saving bank A/c is enhanced for Rs. 8,42,641/- this financial year from previous year's balance, total of which is Rs. 21,19,756/-. Thus a sum of Rs. 18,75,975/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is pertinent to mention here that his wife is working as an Advocate and earned Rs. 5,53,635/- and 6,35,464/- annually for the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2017-18 and seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Muzaffarnagar with the direction that Officer concerned is directed to remain cautious in submitting the property statement in future.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 18.11.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Rakesh Kumar Gautam, Additional District and Sessions Judge (FTC), Mahoba, be laid before Hon'ble Mr . Justice Ajai Kumar Srivastava-I, Administrative Judge, Mahoba for His Lordship's kind perusal and order?
