In the financial years 2016-18 (2016-17 and 2017-18), his total income from Salary and arrears is Rs.18,43,753/- and total deductions /Savings/investments against GIS, Income Tax, NPS, LIC, repayment of Car loan, SIP, Sovereign gold Bond, PPF (including enhancement in his S.B.A/c of Rs. 1,31,513/-) is Rs. 8,22,897/-. Thus a sum of Rs. 10,20,856/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial years 2016-18.

It is pertinent to mention here that his wife Smt. Jaya Priyadarshini (Wife), Age about 25 Year, serving as Judicial Officer, in U.P. Judicial sevice. Net Annual Income in 2016-2017 is Rs. 7,29,909/only, Net Annual income in 2017-2018 is Rs.8,29,504/- only

In this connection, it is submitted that the property statements upto the financial years 2014-16 has already been processed online and laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders under e-service id no. 1777.

The movable and immovable property statements for the financial year 2016-18 has been submitted by the Officer vide his online letter dated 06.01.2021 which was due to be submitted upto the end of the financial year 2018-19 as per two year block policy. As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has submitted that due to unforeseen circumstances, he could not furnish property statement on time. He apologize for that.
