May kindly see the online letter 06.01.2021 received from Sri Suresh Kumar Dubey, Additional Chief Judicial Magistrate (Sr. Div.), Allahabad regarding submission of statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) in prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial years 2018-20 (2018-19 and 2019-20), his total income from Salary and arrears is Rs. 29,68,595/- and total deductions /Savings/investments against GIS, Income Tax, NPS, LIC, repayment of Car loan, SIP & PPF (including enhancement in his S.B.A/c of Rs. 10,69,066/-) is Rs. 21,26,011/-. Thus a sum of Rs. 8,42,584/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2018-20 (2018-19 and 2019-20).

It is pertinent to mention here that Smt Jaya Priyadarshini (Wife) Serving as Judicial Officer in U.P. Judicial Service. In 2018-2019 her net annual income was Rs. 5,97,639/- only. In 2019-2020, her net annual Income was Rs. 17,66,130/- only.

In this connection, it is submitted that the property statements upto the financial years 2016-18 (2016-17 and 2017-18) has already been processed online and laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad for His Lordship's kind perusal and orders under e-service id. no.1778.

The movable and immovable property statements for the financial year 2018-20 (2018-19 and 2019-20) has been submitted by the Officer vide his online letter dated 06.01.2021 which was due to be submitted upto the end of the financial year 2020-2021 as per two year block policy. As such, there is delay in submitting the aforesaid property statements from the part of the officer for which he has not given any reason for delay.

May, if approved, the movable and immovable property statements for the financial year 2018-20 (2018-19 and 2019-20) of Sri Suresh Kumar Dubey, Additional Chief Judicial Magistrate (Sr. Div.), Allahabad be laid before Hon'ble Dr. Justice Kaushal Jayendra Thaker, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
