May kindly see the property statement online received from Smt. Jaya Priyadarshini, Additional Civil Judge (Senior Div.), Allahabad regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1). In the financial years 2014-16 (2014-15 & 2015-16), Gross income from salary Rs. 7,59,878/- and total deductions/savings/ investment against GIS, Income Tax, PPF and the balance of her savings bank account(s) is also increased by Rs.1,11,961/- in this financial year from previous year's balance, total of which is Rs.3,10,211/-. Thus, a sum of Rs.4,49,667/- was therefore available with her to meet out the household expenditure of her family consisting three member in the both of the financial year.

It is pertinent to mention here that Officer's father ( Judicial Officer ) having annual income Rs.14,00,000(approx)..

In this connection, it is submitted that the Officer has already submitted her property statement held at the time of Joining into U.P. Judicial Service online against case id-P00008982020 which is seen by Hon'ble Mr. Justice Rakesh Srivastava, the then Administrative Judge, Allahabad.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. She has submitted movable and immovable property statements of the financial year 2014-16 (2014-15 & 2015-16) vide online dated 24.05.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Smt. Jaya Priyadarshini, Additional Civil Judge (Senior Div.), Allahabad be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Allahabad for His Lordship's kind perusal and orders?
