In this connection, it is submitted that the Officer has already submitted her property statement of the financial year 2014-16 (2014-15 & 2015-16) online against case id-P00008992020 and same has been moved before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Allahabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. She has submitted movable and immovable property statements of the financial year 2016-18 (2016-17 & 2017-18) vide online dated 24.05.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.
