May kindly see the property statement online received from Smt. In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below:

(1). In the financial year 2018-20 (2018-19 & 2019-20), Gross income from salary Rs. 26,45,595/- and total deductions/savings/ investment against NPS, GIS, Income Tax, PPF, RD, FD, LIC policy is Rs.16,85,496. Thus a sum of Rs. 9,60,099/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2018-20 (2018-19 & 2019-20) and the balance of her savings account is also decreased for Rs.2,815 /- this financial year from previous year balance.

It is pertinent to mention here that her husband is working as Judicial Officer' having income Rs.24,04,190 for both the financial year.

In this connection, it is submitted that the Officer has already submitted her property statement of the financial year 2016-18 (2016-17 & 2017-18) online against case id-P00009002020 and same has been moved before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Allahabad for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial year2018-20 (2018-19 & 2019-20) vide online dated 24.05.2021. As such, there is delay in submitting the same. In this regard, officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Smt. Jaya Priyadarshini, Additional Civil Judge (Senior Div.), Allahabad be laid before Hon'ble Mr. Justice Vivek Kumar Birla, Administrative Judge, Allahabad for His Lordship's kind perusal and orders?
