In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2016-18 (2016-17 & 2017-18), his Total income from salary and other sources is Rs. 28,16,534/- (Total income & allowances Rs. 25,96,534/- and Agriculture income Rs. 2,20,000/-) and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, and Insurance policies (LIC and PLI) and the balance of his Saving bank A/c is enhanced for Rs. 4,01,755/- this financial year from previous year's balance, total of which is Rs. 13,30,596/-. In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2014-16 (2014-15 & 2015-16) which is also processed online and laid before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Balrampur, for his Lordship's kind perusal and order on e-service Id no. 1789.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto 31st March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) firstly vide his application dated 21.11.2020. As such, there is delay in submitting the same from the part of the officer and and he has not given any reason for delay.

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Vinod Kumar-V, Additional District and Sessions Judge, Balrampur be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Balrampur for His Lordship's kind perusal and order?
