May kindly see the property statement submitted online received from Sri Vinod Kumar-V, Additional District and Sessions Judge, Balrampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources is Rs. 54,00,235/- (Total income & allowances Rs. 52,00,235/- and Agriculture income Rs. 2,00,000/-) and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, and Insurance policies (LIC, PLI and SBI Life) and the balance of his Saving bank A/c is enhanced for Rs. 7,80,016/- this financial year from previous year's balance, total of which is Rs. 31,73,674/-. Thus a sum of Rs. 22,26,561/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2016-18 (2016-17 & 2017-18) which is also processed online and laid before Hon'ble Mr. Justice Ajit Singh, Administrative Judge, Balrampur, for his Lordship's kind perusal and order on e-service Id no. 1792.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 21.11.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Vinod Kumar-V, Additional District and Sessions Judge, Balrampur be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Balrampur for His Lordship's kind perusal and order?
