

## **Joint Registrar (Judicial)(Budget)**

May kindly see the property statement submitted online received from Sri Mahesh Kumar Kushwaha, presently posted as Additional District & Sessions Judge, Maharajganj, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary is Rs. 48,32,527/- and after total deductions/savings/investments against GIS, GPF, Income Tax, Insurance Policies, the balance of his Savings bank A/c is enhanced for Rs. 10,85,051/- this financial year from previous year's balance, total of which is Rs. 18,82,483/-. Thus a sum of Rs. 29,50,044/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

It is also brought into light that the officer reported PPF Account balance as on 31.03.2018 as Rs. 2,28,012/- and on 31.03.2020 as Rs. 1,31,634/- indicating a withdrawal of Rs. 96,378/-. This amount has been accounted for as income at his disposal for expenditure.

It is pertinent to mention here that in his family, his wife (a practicing advocate) has an annual income is Rs. 3,50,000/- and his daughter has an annual income of Rs. 7,00,000/- in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements for the financial year 2016-18 offline which was seen by Hon'ble Mr. Justice Munishwar Nath Bhandari, the then Administrative Judge, Agra in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 26.11.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mahesh Kumar Kushwaha, presently posted as Additional District & Sessions Judge, Maharajganj, be laid before Hon'ble Mr. Justice Vikas Kunvar Srivastav, Administrative Judge, Maharajganj for His Lordship's kind perusal and orders?
