May kindly see the property statement submitted online received from Sri Sanjay Kumar Shukla, Additional District & Sessions Judge, Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and land held/ immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2017-18 & 2018-19, Total Gross income is Rs.43,55,780/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, NPS, loans, PPF a/cs and the balance of his savings bank account(s) is enhanced for Rs.1,04,361/- this financial year from previous year's balance, total of which is Rs.24,34,134/-. Thus, a sum of Rs.19,21,646/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement at the time of joining into Judicial service which had already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Allahabad in the misc. file of the officer and for the property statements of the financial years 2015-16 & 2016-17, a detailed online office note has been submitted before Hon'ble Mr. Justice Rakesh Srivastava, Administrative Judge, Allahabad Judgeship for kind perusal & order on e-service Id no. 1816.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. Officer has submitted the property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 09.12.2020 and from the perusal of misc. file, it is noticed that officer has submitted the statement of 2018-19 only vide his offline letter dated 18.11.2019. As such, there is delay in submitting the property statement of the financial year 2017-18 from the part of the officer for which officer has stated that "the delay in submission of the statements occurred as he was unaware of the fact that the statement is ought to be sent through Online mode. He sent the statements earlier through Offline mode before the said period." in his reply dated 20.08.2021.

May, therefore, if approved, property statements of the financial years 2017-18 & 2018-19 of Sri Sanjay Kumar Shukla, Additional District & Sessions Judge, Allahabad be laid before Hon'ble Mr. Justice Rakesh Srivastava, Administrative Judge, Allahabad Judgeship for His Lordship's kind perusal and orders?
