May kindly see the online property statements received from Sri Dinesh Pratap Singh, Additional District & Sessions Judge, Sant Kabir Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-18 & 2018-19 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-18 & 2018-19 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-18 & 2018-19, Total Gross Income is Rs.29,08,286/- and total deductions/ repayment/ savings/ investment against GIS, Insurance policies, Income Tax, CPF/NPS, PPF, PLI and the balance of his savings bank account(s) is enhanced for Rs.3,89,667/- this financial year from previous year's balance, total of which is Rs.16,32,871/-. Thus, a sum of Rs.12,75,415/- was therefore available with him to meet out the household expenditure of his family consisting of six members in both of the financial years.

In this connection, it is submitted that the officer has already submitted his property statement for the financial years 2015-17 which had already been seen by Hon'ble Mr. Justice Munishwar Nath Bhandari, the then Administrative Judge, Agra with the direction to the officer not to cause any delay in future while submitting property statement.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-18 & 2018-19 in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-18 & 2018-19 firstly vide online dated 01.12.2020. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to workload and busy in judicial work, he could not submit the said property statement within time. It is, therefore, requested that Hon'ble Court may kindly be pleased to forgive me for delay submission the said property statement", mentioned in his reply dated 26.09.2022.

May, therefore, if approved, property statements of the financial year 2017-18 & 2018-19 of Sri Dinesh Pratap Singh, Additional District & Sessions Judge, Sant Kabir Nagar be laid before Hon'ble Mr. Justice Shiv Shanker Prasad, Administrative Judge, Sant Kabir nagar Judgeship for His Lordship's kind perusal and orders?
