May kindly see the property statement submitted online received from Smt. In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2018-20 (2018-19 & 2019-20), her Total income from salary is Rs. 25,68,694/- and total deductions/savings/investments against NPS, GIS, Income Tax, PPF, STDR, LIC and the balance of his Saving bank A/c(s) is enhanced for Rs.80,853/- this financial year from previous year's balance, total of which is Rs. 11,85,944/-. Thus a sum of Rs.13,82,750/- was therefore available with her to meet out the household expenditure of her family consisting two members in both the financial years.

It is pertinent to mention here that the Officer's husband Sh. Deepak Siwach(Husband)Working in HCL Technologie, Noida At Annual Salary Package of Rs. 12 Lacs and Rs.13.65/- in respective financial years.

In this connection, it is submitted that the officer has already submitted her property statements offline upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Ramesh Sinha, the then Administrative Judge, Muzaffarnagar with the remark that officer concernbed is directed to remain cautious in submitting the property statement in future.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide her application dated 19.12.20. As such, there is no delay in submitting the same from the part of the officer .
