May kindly see the property statement online received from Sri Anurodh Mishra, Judge, Spl Court, CBI Court No. 2, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2015-17 (2015-16 & 2016-17), his gross income from salary is Rs.23,45,982/- and total deductions/Savings/investments against, Deposits in Saving Bank Account, NPS, GIS, Income Tax, NSC, Repayment of car loan and Reliance Tax saver fund are Rs.12,89,404/-. The balance of Rs.87,191/- has increased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.10,56,578/- was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2015-17 (2015-16 & 2016-17).

In this connection, it is submitted that the Officer has already submitted his property statement held at the time of Joining in to U.P. Judicial Service offline, which had already been seen by Hon'ble Mr. Justice M.C. Tripathi, the then Administrative Judge, Chitrakoot in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) vide online dated 13.12.2021. As such, there is day delay in submitting the same. In this regard officer verbatim: " It is submitted that the undersigned could not submit the property statement inadvertently in time due to frequent illness of his parents. The delay caused in submitting the property statement is deeply regretted and apologized. Therefore, the delay may kindly be condoned.."

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Anurodh Mishra, Judge, Spl Court, CBI Court No. 2, Lucknow be laid before Hon'ble Mrs. Justice Sangeeta Chandra, Administrative Judge, Lucknow Judgeship for Her Lordship's kind perusal and orders?
